RESIDENTIAL HEAT PUMP WATER HEATER REBATE PROGRAM

General Information

HOMES THAT QUALIFY FOR A REBATE

- New Construction Homes qualify for the heat pump water heater (HPWH) rebate.
- In existing site built & manufactured homes, the heat pump water heater must replace an electric storage water heater.
- One heat pump water heater rebate per site location.

REBATE AMOUNT

- \$300 rebate for Qualifying any tank size Tier 1 listed on BPA's qualified products list.
- \$600 rebate for Qualifying any tank size Tier 2 – 3 listed on BPA's qualified products list.
- \$800 Split-System Heat Pump Water Heater Listed on BPA's qualified products list.
- The invoice/receipt & installation **must be dated on or after October 1, 2019** to qualify at the current rebate amount.
- *Rebate(s) will not exceed 100% of total heat pump water heater cost and does not cover the cost of installation.

BEFORE INSTALLATION: PRE-APPROVAL

- Pre-installation approval *is* required to qualify for the rebate but an on-site visit is *not* required prior to installation to qualify for the rebate. You or your contractor must submit the Heat Pump Water Heater Rebate Application to Central Lincoln PUD (CLPUD) before installation by email to: rebates@esgroupllc.com or fax to: 503-344-6942.
- Required information for pre-approval: The attached heat pump rebate application with the make & model number.

AFTER INSTALLATION: FINAL DOCUMENTATION

- You or your contractor must submit a final invoice to CLPUD.

QUALITY ASSURANCE INSPECTION

- CLPUD may do a follow-up inspection of your new Heat Pump Water Heater.
- If you are chosen for an inspection, you will be contacted beforehand to schedule a day/time with a CLPUD field representative.

CUSTOMER REBATE CHECKS

- After CLPUD receives your complete application and final invoice, it takes approximately 8 to 10 weeks for rebate checks to be issued and mailed.
